**Sampling Policies & Guidelines**

Exhibitors intending to sample products at the event must adhere to the guidelines below. Compliance is mandatory for all sampling. Failure to follow these guidelines may result in the loss of sampling privileges or removal from the event. Exhibitors must produce and manufacture the food/beverages they are sampling as part of their business.

Food and non-alcoholic beverage samples are limited to 3 oz or less.

Alcohol sampling is limited to the following: Beer - 2 oz | Liquor - .5 oz | Wine -.5 oz | Spirits - .5 oz

Alcohol samples require an OVG Hospitality supervisor, billed at a rate of \$125 for a four-hour minimum and \$25 for each additional hour thereafter.

All food and non-alcoholic beverage sales will require a \$250 buyout fee. Alcohol sales are strictly prohibited.

Samples must be provided at no charge.

Exhibitors sampling must hold a valid Certificate of Insurance and have a copy available upon request during the event.

All food and non-alcoholic beverage sampling and sales requests must be submitted through [ops@acsshows.com](mailto:ops@acsshows.com), while all alcohol sampling requests must be submitted through Jennifer Lyles with OVG Hospitality at [jennifer.lyles@oakviewgroup.com](mailto:jennifer.lyles@oakviewgroup.com).
